### 9. LOCAL CANDIDATURE:

- G. 15 Marks to the contract service who rendered their services in the same specialty for which they are applied in Government institutions
- **12.** Contract service can be calculated from the date of completion of Post-Graduation (Requisite qualification) only.

- 13.
